Si waafaqsan Xeerarka Minnesota Qaybta 13.601, magacaaga, magaalada aad degan tahay, taariikhda shaqada, shaqada isxilqaanka, abaalmarinada iyo maamuusyada waa xog guud oo uu heli karo qof kasta oo codsada macluumaadka. Xogta aad na siiso ee ku saabsan naftaada ayaa sidoo kale loogu baahan yahay in lagugu aqoonsado ayna naga caawiso go'aaminta ku habboonaantaada guddiga(guddiyada) aad codsanayso. Xogtani si sharci ah ayaa loogu baahan yahay, balse diidmada in la bixiyo macluumaadka la codsaday waxay saamayn kartaa awoodda golaha magaalada ay u leeyihiin inay qiimeeyaan codsigaaga. Haddii lagu magacaabo inaad u adeegto guddi ama komishan, si waafaqsan Xeerarka Minnesota Qaybta 13.601, ciwaanka aad degan tahay iyo midkood teleefan lambar ama ciwaan iimayl ah (ama labadaba) oo lagaala soo xiriiri karo ayaa sidoo kale noqda xog guud.
